We would like to invite you to read this full and transparent Privacy Policy on how your data are obtained in the register form of this web, the purpose for which information is used, data collection systems and their management tools.

For the purpose of this Data Protection abovementioned, personal information sent through the web forms will be treated as “web users”.

A high data security and adequate technical and organizational safety-measures are implemented for the users, has been implemented for the users´ data treatment.

Principles applied to personal information

Treatment of personal information complies with the new European Regulation on data protection on:

Your rights when you facilitate data

All persons have the right to know if <http://ecaf.org> is treating personal data.

All persons have the right to:

- Request the access to their personal data
- Request the rectification or elimination of the data
- Request the limitation of the data processing
- Oppose to the processing of the data
- Request the data portability

The data subject may access their personal data, and to request the rectification of the inexact data or to request the data elimination when, inter alia, data when they are no longer necessary for the purpose for which they were collected. Under certain circumstances, the interested party may request the limitation of the management of its data, in which case it will only be saved for the purpose or for the defense of complaints.
